Out of said subscribed capital, Company forfeited 1,14,000 shares in its board meeting dated April 23, 2012 due to non-payment of allotment/ call monies. The statutory auditors of the Company have taken the total issued capital under the head Issued Share Capital in the audited balance sheet as at 31st March, 2013. Further, 46449333 and 50000000 more shares were allotted on January 15, 2014 and July 18, 2014 respectively under preferential offer. The difference because of forfeited shares remains the same and therefore there is a difference in Point no. 10 & 11 and point no. 10 & 15.
